JVar expressed concerns about the possibility of over budgeting. John explained that the goals he budgeted for are lofty, which is why it is important to carefully watch revenues versus expenses. In total, Hildale budgeted less this year than last year.

John continued through the report explaining revenues versus expenditures for the funds.

The Judgment Resolution Fund expenses are anticipated to go down as policies and procedures get into place.

Weston assisted in explaining the Utility portion of the budget to the Board. The numbers match those previously approved by the Utility Board. The Board was informed that the Academy Well is not yet operating, but we are hoping to have it pumping to reduce the purchase of water from Twin City Water Works.
