A. UDOT Representative Update on SR-59 Project

Mike Beck presented a power point on SR-59 Hildale through Apple Valley. He briefly explained that the scheduled roadwork will take approximately 186 working days starting July 2020 with projected completion to next summer. He showed a project overview of the added passing lanes northbound and southbound with additional turn lanes located at the intersection between Apple Valley, Main Street, and SR59. He will give updates every other week for the duration of the project as it progresses.

Councilmember Layton expressed her appreciation for the project happening. Councilmember Dutson expressed his thanks. He mentioned how there have been terrible accidents at the Canaan corner turn and to get safety clear to that corner would be much appreciated.

B. Dixie Business Resource Center
