#1 Call to Order/Roll Call

Meeting called to order at 6:30 pm. Roll was taken, quorum present.

#2. Pledge of Allegiance

Jared led the crowd in the Pledge of Allegiance.

#3. Public Comment

Frederick Zitting expressed concerns on burning tires and speeding vehicles on Uzona avenue. He stated that it is leaving a negative impression with guests and visitors to our community.

#4. Work Session

a. Lease Renewal and expansion of Maxwell Park

Christian presented: We are moving in a different approach then previously discussed. We are going to renew the lease as it currently exists. Then go after additional improvements we also must present a five-year plan and budget. We would need to pursue grant funding to accommodate the plan. We may need to set up a grant committee to pursue different funding sources. There was discussion on expos and additional Government funding sources. The council expressed their support to move forward with the lease as presented.

b. Branding Campaign

Christian presented: The branding campaign was put on hold till we got the City logo done. The council expressed the focus should be on the General Plan.

c. Curfew Ordinance

We are working to synchronize the ordinance with Colorado City. The question is do we move ahead with the curfew on our own or wait for Colorado City. Jared Nicol expressed concern that we have input from the police chief. Maha Layton expressed that we are looking for a cultural shift. This item was moved to the next work session to allow the chief to give input and allow the council time to review the current ordinance.

d. Hildale Holiday Festivities

Mayor Jessop presented: We have volunteers that want to do Christmas at the park, but we need to have electricity available. After discussion on the power supply and different options to bring additional power services to the park. The council directed staff to do additional research on the power supply and costs to expand it.

#5. Review and Prioritize Pending Work Session Items

Christian reviewed a list that was compiled from the pipeline. Jared Nicol discussed how things are being put into and removed from pipeline. The council went over the list and removed some items and set the list to be available for the next work session. Maha Layton presented a plan to help clear up the confusion with the prioritizing of pipeline items. The council had additional discussion on ways to streamline the process for moving forward.

#6. Adjournment

With no other business, meeting adjourned at 08:24 pm.
