Radium Water Treatment Update

The Department has been working closely with Willow Stick, a subcontractor of Bowen & Collins Associates, to locate the water fractures in and around Water Canyon. There is a lot of strong data to show that our original suppositions about the water capacity were correct. Additionally, they've also discovered a potential well source location on Hildale City Property which may prove to be a good secondary option should we need to use it.

We are working closely with the United Effort Plan Trust on a potential donation of water rights worth \$1.6 to \$3 million dollars to support our water replacement project. This donation is absolutely critical to the future success of any water replacement project.

Sunrise Engineering will hopefully deliver a report to the City Councils and the Board on possible Radium Treatment solutions for our existing sources. This much delayed report is long overdue because of issues with communication from treatment providers, which should affect how well the Cities view potential treatment providers in their responsiveness to customer needs.

Finally, preliminary testing conducted on our water treatment plant's green rapid sand filters indicate that there is some radium removal (<20%) in the effluent stream. This could mean, we could use both blending and the static radium removal to temporarily alleviate our contamination, however, there is significant doubt this could include any long term solutions.

Safety Council, Culture and Competence

The Department has identified some problematic adherence to safety protocols and safety procedures. In order to address this serious issue, we're working closely with other departments to implement a safety council for both technicians and management to work together on



implementing strong approaches to safety. We've recently entered into contract for high-visibility uniforms and purchased additional road safety cones for better street marking.

Gas Revenue Updates

We've made some movement getting our gas tank inventory off our lots and into customers by doubling our liquid propane sales for the month of September. We may be acquiring more tank inventory to better accommodate smaller users in more closely confined residential areas like trailer parks. Additionally, we are looking for a Propane Delivery Truck Contractor to deliver propane to customers while some of our techs gain the necessary hazmat certifications on their commercial license.

Mid-Year Budget Revision and Salary Revisions

We are approaching our mid-year budget revisions which heavily are contingent on our prospect for our water resources and the revenue projections after the eviction process in Colorado City is completed. This will include a few changes to employee compensation methods that may include education stipends, increases in retirement, base pay, and bonuses. This will be presented to the board the city councils with comparisons of municipalities with similar population sizes. We will be working closely with the city managers to align our regimen to their directives.

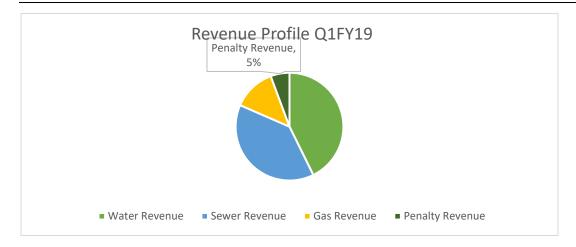

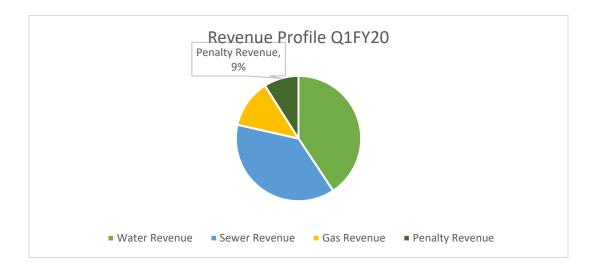

Water Department

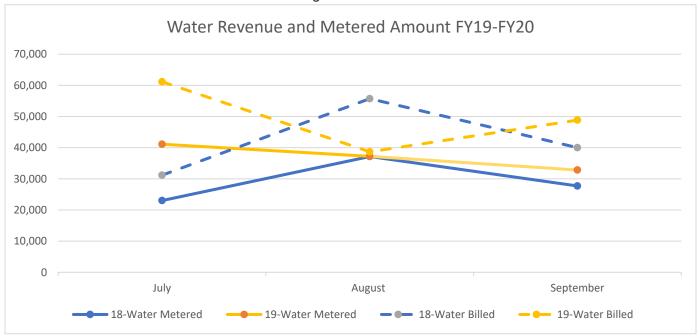
The Water Department saw an overall increase in water usage by 4% from the same quarter last year but saw a fall in base rate and usage revenue.

Usage and Billing Distortion

Over the past year, we've lost some of our community members to tax delinquency disputes. Larger households or commercial users pay higher base rates (\$28.50/month for ¾" meters vs. \$80.00/month for ½" meters) and will pay higher water rates on a tiered basis for higher uses. Thus, a larger number of smaller users could use more water from the system in total, while also decreasing the total revenue from both base rate and metered usage. Additionally, with the increase in construction, water usage through hydrant meters does not incur a base rate thus further confusing our revenue numbers.



- Further evidence can be found below where a marked increase in water billings in August did not translate from an increase in usage:



Sewer Department

The Sewer Department's revenue is primarily base rates, with small variances in usage and as indicated, experiences a slight decline due to the loss of some residents.

Gas Department

Gas department billings are highly dependent on shifting fuel commodity prices, which make easy assumptions on trends more difficult to make and forces the department to rely heavily on usages. So despite doubling our Liquid Propane amount delivered, and increasing our Natural Gas sales in September, prices dipped from \$1.02/gal of propane to \$.88/gal in 2019.

- While it is far from certain, natural gas sales are up while metered propane sales are way down. This may indicate the overall trend in line with both the evictions processing and natural population resettlement.

Report Conclusions

Having Q1 numbers finally in, we can see that the projected revenue shortage for FY2020 due to evictions issues will likely not occur, and we may see positive growth in overall users and revenue as we move into Q2 and Q3 of FY2020. With larger commercial ventures entering our area like the Bee's Marketplace, Production Assembly, and Infab, we anticipate that solid growth will soon come to our area. With the inclusion of developer projects and interest in both Hildale and Colorado city we anticipate solid residential building in the Spring and Summer of 2020.

I would like the Utility Board to authorize the Hildale-Colorado City Gas and Water Departments to enter into an agreement with the owners of Bee's Market place, their construction contractor or authorized agents that will effect to extend service mainlines for Gas and Water services to support Department objectives. Specifically two agreements:

- 1. To provide in-kind labor and construction costs in installing a gas mainline from Central Street to their new construction for a value that shall not exceed \$12,000 from the Department. Bee's Market Place and their agents have tentatively offered to supply \$7,100 of materials for the gas mainline extension, which should cover the cost of materials for extending the mainline. This extension would offer looping, and customer connection opportunities that support the Department's objectives.
- To provide half of the necessary funds, not to exceed \$10,000 in value, to extend the water mainline towards the highway to support the project of connecting the Centennial Park Water District.

I am asking the board to approve the contributions, not to exceed the value listed below, towards these projects and to authorize the Department to enter into these agreements.
